



SHARIA COMPLIANT ACCOUNT TERMS

I, _____, the undersigned (hereinafter referred to as "Client"), represent to BMFN, Ltd. or any subsidiaries or affiliates thereof (hereinafter referred to as "BMFN") that I observe Islamic religious beliefs and can neither receive nor pay interest of any kind within my account(s) at BMFN.

In consideration of BMFN agreeing to offer me an account(s) which is neither credited nor debited interest charges on all Contracts for Difference (hereinafter referred to as "CFD") on currencies and/or futures, on positions which are rolled over and carried forward from previous day's activity (hereinafter referred to as "Interest Free Terms"), I hereby acknowledge, agree to, and understand the following:

- (a) BMFN is offering such account terms in reliance solely on representations made by Client and BMFN is authorized, at any time, to revoke such offering should it have reasonable belief that the Client has misrepresented him/herself in order to acquire such interest free terms. BMFN is not required to provide Client of proof of such reasonable belief should it decide to revoke such terms. Client understands such terms can be revoked and interest RETROACTIVELY applied to all prior activity.
- (b) Client understands and agrees that no transaction within the account(s) shall remain open for longer than ten (10) trading days. At the inception of the eleventh (11th) trading day BMFN reserves the right to apply interest to any position(s) opened within the account and retroactively apply interest to all current and prior positions, even those closed. BMFN makes no written, oral or implied promises or guarantees relating to the duration of time in which the Interest Free Terms will be made available to Client and applied to Client account(s).
- (c) BMFN reserves the right, at any time and from time to time, for any reason in its sole discretion and without liability to Client, to unilaterally amend or cancel the offering of Interest Free Terms which actions shall include, but not be limited to: retroactively accessing swap/interest fees against prior trading should it find reasonable belief of misrepresentations; charging of swap/interest fees on future trading; and/or closure of Client account. BMFN will serve notice to client of such actions delivered to Client's email address provided within his/her account application;
- (d) The Interest Free Terms being offered to Client by BMFN are limited in scope, and apply only to positions maintained in CFDs on currencies and futures. Client agrees and understands that the Interest Free Term do not apply to any other products being offered by BMFN.
- (e) Client indemnifies and holds harmless, BMFN and any of its affiliates, subsidiaries, officers, directors, employees, or agents thereof from any and all liability for any damages, claims or costs whatsoever, or any consequential, indirect, or incidental damages, or any lost profits, trading losses, margin calls or debit balances, sustained or alleged to have been sustained, by Client as a result of the revocation of the Interest Free Terms.
